Information about your Drinking Water

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. GENERAL INFORMATION

NCSUD holds monthly board meetings on the third Thursday of each month at 7 p.m. at NCSUD office located at 2333 Sam Rayburn Hwy., Melissa, unless otherwise noted. We presently have approximately 3500 customers and supply water through approximately 300 miles of water lines.

NCSUD currently employs a total of nine staff members --- a General Manager, Office Manager, three billing clerks, and four field technicians.

We monitor and maintain five pump stations, three water towers along with the transmission and distribution lines to deliver water to our customers. We have a storage capacity of 2,200,000 gallons. We are in the process of beginning construction on a water tower between New Hope and Altoga, which will enhance the service in that area. NCSUD continues to address service requests for new developments.

If you receive an unusually high water bill, please check for leaks. A dripping faucet or fixture can use 3g of water daily. A continuous leak 1/16" in diameter at 60 PSI will use approximately 25,000g in one month.

We strive to maintain the system with efficiency and with the least amount of leaks as possible. If you notice any leaks, please call the office and report them. Please contact the office any time you have a change in your address, phone number, mailing address or property ownership.
