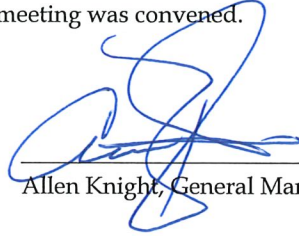
### Agenda

1. Call to order and Roll Call.
2. Hear public comments. (The NCSUD Board will hear public comments for items not listed on the agenda, but any discussion shall be limited to the item being placed on a future agenda for further consideration or, if appropriate, direct the speaker to District staff for more information. Limit individual comments to three minutes with a maximum of fifteen minutes total for public comments.
3. Discuss and take appropriate action regarding North Collin Special Utility District 2024 Annual Audit for fiscal year beginning January 1, 2024 and ending December 31, 2024 (FY2024), as prepared by Rutherford & Taylor Company, P.C.
4. Discuss and take appropriate action regarding NCSUD water rate study with NewGen Strategies and Solutions, LLC.
5. Recess into Executive Session according to Tex. Gov't Code Section 551.071-Private consultation with the District's attorney, Section 551.072 Discussing purchase, exchange, lease, or value of real property, and Section 551.074 Personnel Matters in regards to the following:
